

The School Announcement. Declaration of Intent on Administration with Honesty and Integrity.

The Secondary Education Service Area Office No.25 has valuable management with integrity and transparency according to the policy of Prime Minister of Thailand Mr. Prayuth Chanocha pronounced on September 12th, 2014 with the purpose of promoting the monarchy and preventing corruption. According to the civil code of the year 2009 and the announcement of the Board of Education dated June 22^{nd,} 2011 on honesty and accountability, Integrity and Transparency Assessment (ITA) has to be established.

Manchasuksa School has studied and planned operations to prevent and eliminate fraud for 4 years providing transparency in accountability, and anti-corruption security in corporate operations. Moreover, we believe that the behavior of all the members in our organization must correspond to the needs of the society, and be trusted by the people. Besides, we expect our members to behave honorably while performing their duties and to act according to the established standards.

As a school administrator, I'd like to express my intention to encourage members in my organization to work with integrity and transparency to perform with maximum efficiency. We're ready to protect the benefit of the country and give equal justice for all the people.

I assure you that Manchasuksa School will be a part of the civil service of the government who works with Integrity and Transparency and is ready for inspection. Following this vision of Integrity and Transparency Manchasuksa School is aiming to improve the quality of education which corresponds to international standards according to the Sufficient Economy Philosophy of the year 2020.

Therefore, I declare:

I will be in charge to run my school with awareness and I will be able to act with full intelligence, with absolute honesty, and with a conscious mind, knowing what is right, and what is wrong, and what should be done to ensure that the work is done without damage.

By complying with Good Governance Principles, I will resist all forms of corruption and will aim to give people maximum benefits. In addition, we will provide a good service for his Majesty the King.

On behalf of the executives of Manchasuksa School hereby we declare our intentions. We will be in charge to run our school with honesty following the principles of Good Governance, integrity and transparency and responsibility to gain the public's confidence that Manchasuksa School has a strong desire to fight all forms of corruption and is determined to be an honest school.

By proceeding as follows:

- 1. Acting strictly according to the law, and other regulatory procedures, providing our staff with legal support.
- 2. Building up awareness in fighting corruption, separating private and public profits. We have a strong intention to make an efficient internal balance control so that the staff at school be aware of the consequences of corruption.
- 3. Denying all forms of corrupt behavior, not tolerating the corruption that leads to Social Sanction which can affect the staff ashamed or fear to making corruption.
- 4. Raising the awareness of the consequences of corruption and raising the awareness of fighting corruption among the students.
- 5. Establishing the control of cooperative activity in fighting corruption.
- 5.1 Acting in accordance with the National Strategy Plan on the prevention of the third-stage corruption acts for the years 2017-2021.
- 5.2 All government agencies and staff are putting their efforts together to prevent and defy all forms of corruption in the Office of the Basic Education Commission including Primary and Secondary Educational Service Area Office.

- 5.3 Establishing research, collecting knowledge on the prevention and control of corruption.
- 5.4 Sharing the knowledge about the 3rd phase of National Strategy to prevent and control corruption for the years 2017-2021. Organizing moral support for the central executive, district executive, and school education personnel of all levels of the basic education management with the purpose to create knowledge, understanding and participation in the promotion of the campaign to students, parents and the general public, participating in anti-fraud activities and establishing a network to prevent and control corruption.
- 5.5 Providing information on surveillance and inspection to counter fraud among educational staff across the country, such as directors, school administrators, educational staff in all levels of education management, building understanding and encouraging participation in promoting the campaign to students, parents and all public in general to fight together against fraudulent activities.
- 5.6 We're going to follow moral principles and establish transparency for all school departments and follow a set course according to National Strategy Plan for the prevention the third-stage corruption for the years 2017-2021.
- 5.7 We've launched a network of communication channels, and promotions to support the operation as a network of cooperation to prevent and fight corruption.
- 5.8 Sharing the information, guidance, follow-up and the evaluation of such cooperation.
- 5.9 Bringing together other measures to prevent and combat fraud of any kind with the best of our abilities.
